Methodology

- The online survey was conducted May 16-September 30, 2018
- The study was sponsored by Institute of Prison Ministries Billy Graham Center at Wheaton College and Good News Jail and Prison Ministry
- The first source of sample was a national list of jails obtained from the National Public Safety Information Bureau. Those with email addresses were invited to complete the online survey.
- In addition to the initial list, the Institute of Prison Ministries did additional lookups identifying additional jails not included in the first sample.



Methodology


- The Institute of Prison Ministries made telephone calls to jails in 14 states (AL, AK, AR, AZ, CO, CT, DC, DE, GA, HI, IA, IL, MI, TX) to encourage response to the online survey.
- The completed sample is 309 surveys (150 from the first email invites and 159 from follow-up calling and emails)
- The sample provides 95% confidence that the sampling error does not exceed +5.1%
- Margins of error are higher in sub-groups



Survey Responses of Initial Recipients




34% say their job position or title is "Jail Administrator"



Other: Lieutenant 2%, Program coordinator 2%, Deputy 1%, Under/assistant sheriff 1%, Other 6%




35% say they are responsible for the hiring and screening chaplains; 23% say another staff member handles this





48% of the participating facilities are in the South




93% of participating facilities are county jails




"Which best reflects the "model" of working or coordinating with religious service providers at your jail?"

We work with specific individuals who contact the jail directly to offer their services








66% say their facility has 1 to 3 chaplains serving






51% say that chaplains are not in a "paid" position



58% say that chaplains in a paid position are employed by a ministry or non-profit organization






44% say chaplains are required to work four hours a week or less




"What specific training is required of chaplain(s)?"



63% say there are no minimum education requirements for chaplains




"Are there specific requirements for chaplain(s) to have previous ministry experience?"







64% say that chaplains are required to have one year or less of experience



"Are there additional credentials and or/experience required for chaplain(s)?"




58% say that chaplains are required to maintain a faith group endorsement






90% say that background checks are conducted on chaplains




36% say that an individual with a felony conviction would be eligible to be appointed as a chaplain



66% say that it would have to be 5 years or more since someone's release to be considered as a chaplain




"What are the roles and responsibilities of your designated chaplain?"








45% say that chaplains periodically submit a report of activities






72% say an activity report is submitted monthly

"At your facility, which of the following best reflects who hires or coordinates chaplain(s)?" (Asked of initial recipients)

- Those at facilities with 1-49 inmates (43%) and 50-249 inmates (49%) are more likely to select "I am responsible" than those at facilities with 250-999 inmates (22%) and 1,000+ inmates (19%)
- Those at facilities with 250-999 inmates (11%) and 1,000+ inmates (12%) are more likely to select "I delegate this to a designated agency/non-profit" than those at facilities with 50-249 inmates (2%)
- Those at facilities with 250-999 inmates (12%) and 1,000+ inmates (17%) are more likely to select "A staff member delegates this to an agency/non-profit" than those at facilities with 1-49 inmates (2%) or 50-249 inmates (3%)
- Those at facilities in the South (43%) are more likely to select "I am responsible" than those at facilities in the Midwest (27%)



"Is your facility a..." (Asked of initial recipients)

- Those at facilities with 1-49 inmates (100%) and 50-249 inmates (98%) are more likely to select "County jail" than those at facilities with 250-999 inmates (90%) and 1,000+ inmates (79%)
- Those at facilities with 250-999 inmates (8%) and 1,000+ inmates (17%) are more likely to select "Regional jail" than those at facilities with 1-49 inmates (<1%) and 50-249 inmates (2%)
- Those at facilities in the Midwest (99%) are more likely to select "County jail" than those at facilities in the South (88%)
- Those at facilities in the South (10%) are more likely to select "Regional jail" than those at facilities in the Midwest (1%)

 Those at facilities with 250-999 inmates (84%) and 1,000+ inmates (95%) are more likely to select "Yes" than those at facilities with 1-49 inmates (66%)



"If you have officially designated chaplain personnel, how many chaplains are officially used at the jail (including yourself if you are a chaplain)?"

- Those at facilities with 50-99 inmates (43%) are more likely to answer
 "2-3" than those at facilities with 250-999 inmates (25%)
- Those at facilities with 250-999 inmates (15%) and 1,000+ inmates (18%) are more likely to answer "More than 10" than those at facilities with 50-249 inmates (4%)
- Those at facilities in the West (50%) are more likely to answer "2-3" than those at facilities in the Midwest (21%)
- Those at facilities in the Midwest (21%) are more likely to answer "6-10" than those at facilities in the South (8%)



"Are any of these chaplain(s) in a "paid" position by an employer (Jail or other employer)?"

• Those at facilities with 250-999 inmates (58%) and 1,000+ inmates (76%) are more likely to select "Yes" than those at facilities with 1-49 inmates (13%) and 50-249 inmates (25%)

 Those at facilities in the South (43%) are more likely to select than those at facilities in the Midwest (18%)

"Approximately how many hours are chaplains required to work each week?"

- Those at facilities with 1-49 inmates (52%) and 50-249 inmates (36%) are more likely to answer "0" than those at facilities with 250-999 inmates (10%) and 1,000+ inmates (8%)
- Those at facilities with 1-49 inmates (39%) are more likely to answer "1-4" than those at facilities with 250-999 inmates (17%) and 1,000+ inmates (6%)
- Those at facilities with 250-999 inmates (24%) are more likely to answer "20-39" than those at facilities with 1-49 inmates (<1%) and 50-249 inmates (6%)
- Those at facilities with 250-999 inmates (37%) and 1,000+ inmates (67%) are more likely to answer "40+" than those with 1-49 inmates (<1%) and 50-249 inmates (11%)

- Those at facilities in the Midwest (42%) are more likely to answer "0" than those in the South (16%) and West (8%)
- Those at facilities in the West (40%) are more likely to answer "1-4" than those at facilities in the Midwest (19%) and South (16%)
- Those at facilities in the South (37%) and West (40%) are more likely to answer "40+" than those at facilities in the Midwest (18%)



"What specific training is required of chaplain(s)?"

Safety/Security

- Those at facilities with 250-999 inmates (82%) and 1,000+ inmates (89%) are likely to select than those at facilities with 1-49 inmates (39%) and 50-249 (61%) inmates
- Those at facilities in the South (75%) and West (84%) are more likely to select than those at facilities in the Midwest (58%)

PREA (Prison Rape Elimination Act)

- Those at facilities with 250-999 inmates (75%) and 1,000+ inmates (89%) are more likely to select than those at facilities with 1-49 inmates (31%) and 50-249 inmates (47%)
- Those at facilities in the West (78%) are more likely to select than those at facilities in the Midwest (52%)



"What specific training is required of chaplain(s)?" (continued)

Volunteer Orientation

- Those at facilities with 250-999 inmates (90%) and 1,000+ inmates (84%) are likely to select than those at facilities with 1-49 inmates (36%) and 50-249 (64%) inmates
- Those at facilities in the South (76%) and West (88%) are more likely to select than those at facilities in the Midwest (60%)



"What minimal educational requirements, if any, must the chaplain(s) meet?"

- Those at facilities with 1,000+ inmates are the most likely to select "Bachelor's degree" (38%), followed by those with 250-999 inmates (17%)
- Those at facilities with 1-49 inmates (79%) and 50-249 (82%) are more likely to select "No minimum" than those at facilities with 250-999 inmates (58%) and 1,000+ inmates (22%)
- Those at facilities in the Midwest (74%) are more likely to select "No minimum" than those at facilities in the South (54%)



"Are there specific requirements for chaplain(s) to have previous ministry experience?"

 Those at facilities with 250-999 inmates (61%) and 1,000+ inmates (59%) are more likely to select "Yes" than those at facilities with 50-249 inmates (37%)



"How many years of ministry experience are chaplain(s) required to have?"

- Those at facilities with 1-49 inmates are the most likely to answer "0" (69%)
- Those at facilities in the Midwest (45%) are more likely to answer "0" than those at facilities in the South (11%)
- Those at facilities in the South (29%) are more likely to answer "2-4" than those at facilities in the Midwest (6%)



"Are there additional credentials and or/experience required for chaplain(s)?"

Clinical Pastoral Education (CPE)

No significant differences

Addictions

 Those at facilities with 1,000+ inmates (17%) are more likely to select than those at facilities with 1-49 inmates (3%)

Counseling

Those at facilities with 250-999 inmates (27%) and 1,000+ inmates (33%) are more likely to select than those at facilities with 50-249 inmates (12%)



"Are chaplains required to possess and maintain an endorsement, ordination or commission from a faith group?"

• Those at facilities with 250-999 inmates (71%) and 1,000+ inmates (75%) are more likely to select than those at facilities with 1-49 inmates (38%) and 250-249 inmates (45%)



"Do you conduct background checks on chaplains?"

 Those at facilities with 250-999 inmates (94%) are more likely to select "Yes" than those at facilities with 1-49 inmates (80%)



"Would an individual with a felony conviction be eligible for appointment as a chaplain?"

- Those at facilities with 250-999 inmates (44%) and 1,000+ inmates (50%) are more likely to select "Yes" than those at facilities with 1-49 inmates (20%) and 50-249 (28%)
- Those at facilities in the West (59%) are more likely to select "Yes" than those at facilities in the Midwest (35%) and South (29%)

"What are the roles and responsibilities of your designated chaplain?"

Manage volunteers

- Those at facilities with 250-999 inmates (69%) and 1,000+ inmates (86%) are more likely to select than those at facilities with 1-49 inmates (20%) and 50-249 inmates (40%)
- Those at facilities in the South (61%) are more likely to select than those at facilities in the Midwest (44%)

Provide volunteer training

Those at facilities with 250-999 inmates (52%) and 1,000+ inmates (71%) are more likely to select than those at facilities with 1-49 inmates (17%) and 50-249 inmates (29%)

Schedule religious programs

Those at facilities with 250-999 inmates (72%) and 1,000+ inmates (91%) are more likely to select than those at facilities with 1-49 inmates (49%) and 50-249 inmates (54%)

Manage religious library

Those at facilities with 250-999 inmates (67%) and 1,000+ inmates (71%) are more likely to select than those at facilities with 1-49 inmates (23%) and 50-249 inmates (38%)

Process Request for religious accommodations

Those at facilities with 250-999 inmates (68%) and 1,000+ inmates (83%) are more likely to select than those at facilities with 1-49 inmates (26%) and 50-249 inmates (34%)

Deliver death notifications

- Those at facilities with 250-999 inmates (67%) and 1,000+ inmates (83%) are more likely to select than those at facilities with 1-49 inmates (9%) and 50-249 inmates (31%)
- Those at facilities in the South (59%) are more likely to select than those at facilities in the Midwest (35%)

"What are the roles and responsibilities of your designated chaplain?" (continued)

Counsel inmates

• Those at facilities with 1,000+ inmates (91%) are more likely to select than those at facilities with 1-49 inmates (60%) and 50-249 inmates (68%)

Make contacts with offender families

- Those at facilities with 250-999 inmates (47%) and 1,000+ inmates (71%) are more likely to select than those at facilities with 1-49 inmates (11%) and 50-249 inmates (19%)
- Those at facilities in the South (46%) and West (44%) are more likely to select than those at facilities in the Midwest (21%)

Attend community functions

Those at facilities with 250-999 inmates (37%) and 1,000+ inmates (60%) are more likely to select than those at facilities with 1-49 inmates (21%) and 50-249 inmates (6%)

"What are the roles and responsibilities of your designated chaplain?" (continued)

Assist with reentry needs

Those at facilities with 250-999 inmates (41%) and 1,000+ inmates (54%) are more likely to select than those at facilities with 1-49 inmates (14%) and 50-249 inmates (24%)

Counsel staff

- Those at facilities with 250-999 inmates (60%) and 1,000+ inmates (74%) are more likely to select than those at facilities with 1-49 inmates (17%) and 50-249 inmates (32%)
- Those at facilities in the South (54%) are more likely to select than those at facilities in the Midwest (38%)



"Is the chaplain provided office space in your facility?"

- Those at facilities with 250-999 inmates (59%) and 1,000+ inmates (71%) are more likely to select "Yes a private space" than those at facilities with 1-49 inmates (9%) and 50-249 inmates (18%)
- those at facilities with 1-49 inmates (9%) and 50-249 inmates (18%)
- Those at facilities with 1-49 inmates (82%) and 50-249 inmates (58%) are more likely to select "No" than those at facilities with 250-999 inmates (24%) and 1,000+ inmates (9%)



"What training/materials do you (or the jail) provide for volunteers"

Orientation

- Those at facilities with 1-49 inmates are the least likely to select (43%)
- Those at facilities in the South (79%) and West (78%) are more likely to select than those at facilities in the Midwest (56%)

Safety training

- Those at facilities with 1-49 inmates are the least likely to select (26%)
- Those at facilities in the South (69%) and West (69%) are more likely to select than those at facilities in the Midwest (45%)

Handbook or other written material

 Those at facilities with 1-49 inmates are the least likely to select (26%)

"Is there a periodic report of activities (e.g., # of activities/events per month, # of attendees as activities/events, etc.) chaplains must submit?"

 Those at facilities with 250-999 inmates (60%) and 1,000+ inmates (89%) are more likely to select "Yes" than those at facilities with 1-49 inmates (6%) and 50-249 inmates (27%)



"How often is this activity report submitted?"

No significant differences



"Do you have any type of system or program in place that measures the impact that participating in religious services has on inmates?"

 Those at facilities with 1,000+ inmates (31%) are more likely to select "Yes" than those at facilities with 1-49 inmates (11%) and 50-249 (6%)
